China

Hong Kong – [University of Hong Kong \(Exchange\)](#)

The University of Hong Kong is the territory's oldest institute of higher learning and also an internationally recognized, research-led, comprehensive university. With over 7.4 million people of various nationalities in a 426 sq mi territory, Hong Kong is one of the most densely populated places in the world. Accounting students might be interested in the classes required for the University of Hong Kong's Bachelor of Business Administration in Accounting and Finance.

Tamkang University is located in New Taipei City, which is a city of about 4 million. Tamkang is a university dedicated to ideas, vision, and creativity. Accounting majors could take classes like: Economics, Accounting, and AI and Programming Language.

Budapest - [AIFS Study Abroad in Budapest](#)

Corvinus University is the leading higher education institution in Hungary. Its Hungarian students go through a rigorous academic selection and its international students come from over 80 countries around the world. Hungary has a long tradition of higher education and has produced many Nobel prize winners, scientists and inventors. Some courses include Elements of Accounting, Managerial Accounting, Introduction to International Business, and Marketing.

Italy

Australia

Adelaide - [IFSA- University of Adelaide](#)

The University of Adelaide is located right in the heart of the city of Adelaide, which was recently called "Australia's best kept secret" thanks to its great weather, never-ending festivals, food and wine culture and affordability. Take accounting courses like Accounting Foundations, Cost and Management Accounting, Accounting Information Systems, Accounting Theory, and Strategic Management Accounting.

Gold Coast - [IFSA- Griffith University](#)

Study at one of the Asia-Pacific region's most progressive and dynamic universities offering a wide range of studies and many interdisciplinary offerings. Study Abroad students who attend this program are eligible for Griffith's prestigious Honours College. New Zealand

The University of Otago has been rated by international students as one of the top universities in New Zealand in terms of quality of learning, living, support, and student services. Students will study alongside "Kiwis" and other international students at New Zealand's oldest university. Take accounting courses like Financial Accounting and Reporting, Accounting and Information Systems, Management Accounting, and Sustainability Accounting and Reporting.

Students at Victoria University of Wellington (VUW) will be able to take a wide variety of courses with Kiwis and other international students in one of New Zealand's most comfortable and cosmopolitan cities. Located in the capital, VUW offers top-level academics with a strong focus on regional issues. Some of the courses available here include Financial Accounting, Introduction to Accounting Systems, Fraud Auditing, Management Accounting, and Government Accounting and Finance.

FACULTY-LED PROGRAMS

Poland

Krakow and Warsaw – [Economics of Poland](#)

3 credits for BUSA 377. Takes place during Summer (14-16 days in May). Students will learn, through studying theories and through practical experiences, the concepts relative to international aspects of economics.

Portugal and Spain

Lisbon and Bilbao – [Sports Management and Law in Portugal and Spain](#)

3 credits in BUSA 377. Takes place during Winter Break (10-13 days in December/January). Students will examine the legal, financial, moral, and policy issues and disputes that arise in the world of amateur and professional sports.

Edinburgh – [Going Green: The Impact of Sustainability on International Business and Culture in Scotland](#)

3 credits for BUSA 377. Takes place during Summer (12-16 days in May or June). Students will study the impact of sustainability on business and culture in an international context.

3 credits for FIN 311. Takes place during Spring Break (9-11 days in March). Students will visit financial institutions, corporations, and other relevant cultural locations as they study monetary policy, securities training, financial management, and the money management industry.
